Signals Preparation – Online

## **Course Cost**

£180 including MCA Signals exam.

## **Entry Requirements**

This course is a required element of the training needed for obtaining the UK Officer of the Watch Certificate of Competency. You can read about the requirements in [para. 3.2 of Merchant Shipping Notice \(MSN\) 1856 Amendment 1](#).

## **Duration**

Learners should be able to complete the online learning material and formative assessments within 3-6 months of enrolment and must book their MCA Signals exam within the same year. All enrolments will end on 31<sup>st</sup> July of the year of enrolment. The maximum enrolment period is one academic year. Please note that the exam takes place on campus at Fleetwood Nautical Campus, half day is required AM or PM. You will need to attend to undertake this.

## **Aim of course**

This online course is designed to prepare you for the MCA Signals exam conducted by MCA approved examiners within the College, covering topics such as transmitting and receiving of Morse Code, identification of signal flags, understanding the single letter meaning of flags, and general communications.

This online course is for students who cannot attend the fulltime Signals course at college but wish to book and sit the MCA Signals exam.

Once enrolled, you will receive an email from the college with login details to gain access to the College virtual learning environment and the online learning materials for Signals. If the published exam dates are not suitable, there is the option of arranging an exam date at your convenience (subject to lecturer availability).

To meet the requirements for booking a MCA Signals exam at college, students must complete and pass four formative assessments and a pre-college test for Signals.

## **Career Options and Progression**

Completion of this course, and all the other elements listed in MSN 1856 para. 3.2 will enable you to undertake the Officer of the Watch oral examination.

## **Fees, Cancellation and Transfer Policy**

### **Off-Premises and Distance Contracts Only**

- Your contract with the College is formed on the date of your booking. You have a statutory right to cancel or withdraw your booking. Under Regulation 30 of the Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013 this statutory termination right ends 14 days after the day on which the contract is entered into.
